1. General Information

a. Clinic Information

- The clinic will be run under FEI <http://www.fei.org> and Equestrian Australia (EA) rules. Please familiarise yourself with these rules at <http://www.equestrian.org.au/driving>
- Clinic information, timetable and any changes to schedule plus all relevant information will be posted outside Stable Block F.
- Entries (maximum of 3 per driver) will be received until clinic is fully booked thereafter lesson requests will be short listed for non-guaranteed openings.
- Clinic entry - All horses/ponies will be required to report to Event Steward at AELEC for inspection before going to stabling
- Lessons of 45 minutes duration at the discretion of Boyd Exell. Every effort will be made to run to scheduled times.
- Athlete (not groom) entry will include Fencesitting access
- Fence sitters are welcome see entry form for details
- Coloured entry badges will be issued and are to be presented when accessing lesson areas.
- Only athletes and their nominated grooms with paid entry will be permitted to participate in the clinic
- All athletes must organise their own groom. Sharing grooms is not recommended.

b. Arrival Time

The Australian Equine Livestock Event Centre (AELEC) is a gated venue. The venue will only be open to Clinic participants from Tuesday 2nd October 2018 at 1:00pm onwards. Entry into the stabling and camping area prior to this time is not permitted, parking is available in the AELEC day parking area. All competitors will be given a gate code upon payment of stabling and camping fees (book directly through AELEC – (02) 6767 5658 or see website for further details www.aelec.com.au).

Horses and Ponies are not to enter Stable area until checked by Stewards upon arrival at Stable Block F.

c. Stabling and Camping.

AELEC manage all aspects including fees and bookings for camping, stabling and vehicle parking. Please see their web site at www.aelec.com.au for details or via phone on (02) 6767 5658. All Carriage Driving Horses/Ponies will be in Stable Block F only.

**IMPORTANT - Bookings for stabling/camping open from 1st August 2018 and must be booked before 28th September 2018.*

d. Helmets

HDT Club requires all Athletes / Grooms aged 18 years and under to wear a helmet at all times when mounted on a carriage. EA General Regulations Act 1 22. Strongly recommends athletes & grooms are to wear a helmet when mounted on a vehicle. Helmets must comply with one of the following standards:

- AS/NZS 3838 (Current Australian Standard)
- VG1 (interim European Standard)
- ASTM F1163 (Current US Standard)

e. Back Protectors

HDT requires all Athletes / Grooms aged 18 years and under to wear a back protector at all times when mounted on a carriage and highly recommends that when training for Marathon Obstacles all athletes & grooms are to wear back protectors when mounted on a vehicle..

f. Catering

On Thursday 4th October 2018 the HDT Club will host a Welcome Dinner for all clinic participants and grooms at AELEC outside the AELEC kitchen from 7pm. All welcome.

AELEC provide an all-day canteen in the Main Indoor Arena Concourse from Thursday – Sunday plus the 24 hour Star Petrol Station and Café is located just outside AELEC main gate..

g. Dogs

Dogs MUST be on leads at all times and all dog waste, MUST be collected by handler. No dogs are allowed in the toilet, shower or laundry blocks

2. Membership and Insurance for Athlete and Groom

An EA Event Waiver (attached) must be signed by each athlete and groom and included with your entry

- Athletes and grooms must be a member of the EA; or
- A member of Horse Driving Trials Club (HDT); or
- A member of an EA affiliated Club; or
- Take out 'One Event' membership of Horse Driving Trials Club (\$40.00 see entry form)

Note: A HDT annual Membership: Driver \$60.00 / Groom \$30.00 (see attached membership form)

A One Event membership will provide public liability insurance for athlete / groom from 1st to 8th

October 2018 and only whilst on the clinic/competition grounds.

HDT Club membership and a One Event Membership insurance is limited to public liability insurance

3. Risk Warning and Disclaimer

Horse sports are dangerous activities and can result in serious injury (including death) and loss. All persons who ride, drive or tend to a horse on the grounds do so entirely at their own risk. Neither Equestrian Australia, AELEC, the NSW Carriage Driving Council, Equestrian NSW, the Organising Committee, Horse Driving Trials Club NSW Inc. or any other member thereof, accepts any liability for any personal injury (including death) suffered by any person from, or relating to any incident involving a horse and handler or driver or rider. Waiver to be signed and sent back with Entry Form.

4. Code of Conduct

The HDT Club works towards ensuring the best outcome for participants and hopes they get maximum enjoyment and learning from our clinics.
