1. Clinic Information

- The clinic will be run under FEI <http://www.fei.org> and Equestrian Australia (EA) rules. Please familiarise yourself with these rules at <http://www.equestrian.org.au/driving>
- Clinic information, timetable and any changes to schedule plus all relevant information will be posted at the office
- Only athletes and their nominated grooms with paid entry will be permitted to participate in the clinic
- All athletes must organise their own groom. Sharing grooms is not recommended.
- Fence sitters are welcome see entry form for details
- Athlete badges will be issued and should be worn to gain access to lesson area.

2. Helmets

EA General Regulations Act 1 22. Strongly recommends athletes & grooms are to wear a helmet when mounted on a vehicle. Helmets must comply with one of the following standards:

- AS/NZS 3838 (Current Australian Standard)
- VG1 (interim European Standard)
- ASTM F1163 (Current US Standard)

3. Back Protectors

EA Highly recommends that when training for Marathon Obstacles, that all athletes & grooms are to wear back protectors when mounted on a vehicle. When training for Marathon obstacles HDT recommends that all mounted athletes and grooms wear Back Protectors during the clinic.

4. Membership and Insurance- An EA Event Waiver (attached) must be signed by each athlete and groom and included with your entry

- Athletes and grooms must be a member of the EA; or
- A member of Horse Driving Trials Club (HDT); or
- A member of an EA affiliated Club; or
- Take out One Event membership of Horse Driving Trials Club (\$30.00 see entry form)

:

HDT annual Membership: Driver \$60.00 / Groom \$30.00 (see attached membership form)

One Event membership fee will cover athlete / groom from 7th to 8th July 2018 and only whilst on the clinic grounds.

HDT Club membership and a One Event Membership insurance is limited to public liability insurance

5. Refunds

A part refund of clinic entry monies will be available upon receipt of a Veterinary Certificate of unsoundness or a Doctors Certificate as follows:

Documentation submitted by 5pm Friday 29th June 2018 will attract a 50% refund and if submitted between 30 June 2018 and commencement of the clinic a 25% refund will apply.

You may wish to recoup clinic entry costs by on-selling your entry.

6. Stabling and Camping

Stables and Powered Camping Sites, if required, should be booked on attached entry form. Stables will be allocated by the organising committee, only one horse/pony per stable. Only shavings allowed in stables no straw.

7. Dogs – MUST be on leads at all times and all dog waste MUST be collected by handler. No dogs are allowed in the amenities blocks.

8. Catering

On 7th July 2018 at 6pm the Horse Driving Trials Club will host a 'Welcome BBQ' for all clinic entrants and officials at the Moonbi Rec Grounds.

All welcome please bring a chair and what you like to drink.



9. Risk Warning and Disclaimer

Horse sports are dangerous activities and can result in serious injury (including death) and loss. All persons who ride, drive or tend to a horse on the grounds do so entirely at their own risk. 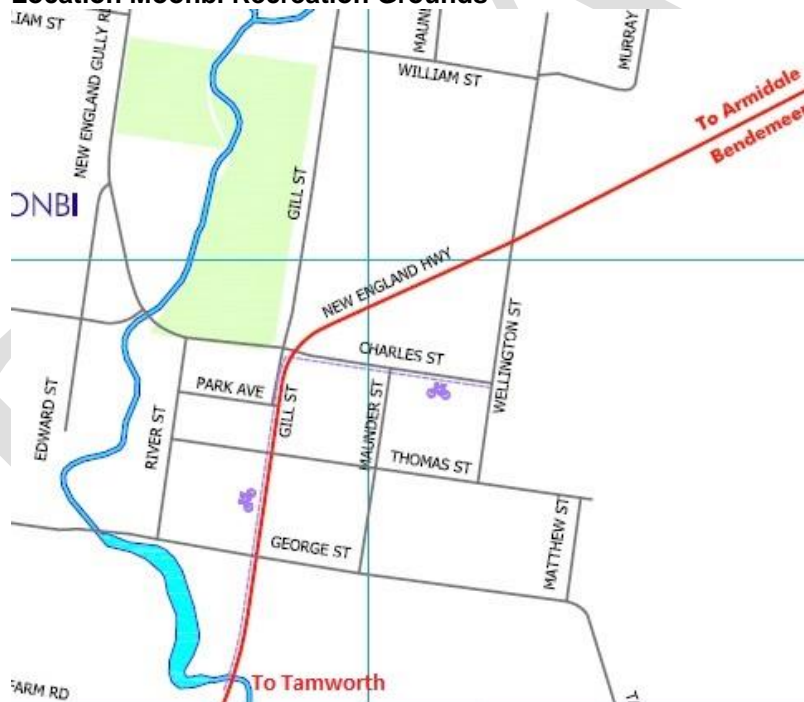
